## **Our Commitment to Privacy**

Your privacy is important to us. To better protect your privacy, we provide this notice explaining our information practices and the choices you can make about the way your information is collected and used.

#### The information we collect

This notice applies to all information collected or submitted to RHA via this website. The types of personal information collected by RHA include:

**Identity Data** includes first name, maiden name, last name, username or similar identifier, marital status, title, date of birth, gender and copies of identity documents such as driving licences.

Contact Data includes billing address, delivery address, email address and telephone numbers.

Financial Data includes bank account and payment card details.

**Technical Data** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this website.

**Profile Data** includes your username and password, your interests, preferences, feedback and survey responses.

Usage Data includes information about how you use our website, products and services.

**Marketing and Communications Data** includes your preferences in receiving marketing from us and our third parties and your communication preferences.

### How we collect your personal data

We use different methods to collect data from and about you including through:

**Direct interactions.** You may give us your identity, contact and financial data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you:

- register an intertest in the RHA's collective claim.
- sign up to the RHA's collective claim.
- create an account on our website;
- subscribe to our service or publications;
- request marketing to be sent to you;
- give us some feedback.

Automated technologies or interactions. As you interact with our website, we may automatically collect technical data about your equipment, browsing actions and patterns. We collect this personal data by using cookies, server logs and other similar technologies.

**Third parties or public available sources.** We receive personal data about you from various third parties and public sources including the DVLA or the Office of the Traffic Commissioner.

### The way we use information

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract, we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

We may share your information with our business partners and other external parties only to the extent necessary to complete the order or to comply with legal requirements.

You can register with our main website <u>www.rha.uk.net</u> if you would like to receive news and updates on our new products and services. Information you submit on our website will be used for this purpose, you can unsubscribe at any time.

Generally, we do not rely on consent as a legal basis for processing your personal data other than in relation to sending third party direct marketing communications to you via email or text message. We have set out below, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

Note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data.

## International transfers

We do not envisage transferring your personal data outside the European Economic Area (EEA).

However, if we or a third party transfer your personal data out of the EEA, we ensure a similar degree of protection is afforded to it by ensuring at least one of the following safeguards is implemented:

- We will only transfer your personal data to countries that have been deemed to provide an adequate level of protection for personal data by the European Commission.
- Where we use certain service providers, we may use specific contracts approved by the European Commission which give personal data the same protection it has in Europe.
- Where we use providers based in the US, we may transfer data to them if they are part of the Privacy Shield which requires them to provide similar protection to personal data shared between the Europe and the US.

## Our Commitment to Data Security

To prevent unauthorised access, maintain data accuracy and ensure the correct use of information, we have put in place appropriate physical, electronic and managerial procedures to safeguard and secure the information we collect.

### How long will you use my personal data for?

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we

process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

Subject to the above, we envisage that your personal data (including contact, identity, financial and transaction data) will be kept for the period of the contract plus 6 years and 4 months.

### Your rights

Access	You can ask for the personal information we hold about you and for details about how and for what purpose we use your information.
Rectification	You can ask us to correct any personal information that's inaccurate or incomplete
Objection	You can ask us to stop processing your personal information in certain circumstances

Restriction	You can ask us to temporarily stop processing your personal information in certain circumstances
Erasure	You can ask us to delete any information we hold about you if the law and our data retention policies no longer require us to keep it.
Data Portability	You can ask us for copies of the information we hold about you so that you can move, copy or transfer personal data easily from one IT environment to another.
Automated decisions/profiling	You have the right not to be subject to a decision based solely on automated processing, including profiling, which has legal effects for you or affects you in any other significant way.
Marketing	You have the right to opt out of any marketing of products and RHA services you do not wish to receive and will not be contacted.

We will get your express opt-in consent before we share your personal data with any company for marketing purposes.
